**Policy** 

### Fiscal Management

The Board of Education recognizes that money and money management are a necessary support of the whole school program. To make that support as effective as possible, the Board intends:

- A. To encourage financial planning through effective budget procedures;
- B. To explore all practical sources of dollar income;
- C. To guide the expenditure of funds so as to extract the greatest educational returns;
- D. To expect top-quality accounting and reporting procedures; to adopt and implement sound fiscal procedures. The business administrator/board secretary under the direction of the Superintendent shall prepare a manual of procedures to ensure that all business operations of the District are carried out uniformly, efficiently and in accordance with law and board policy;
- E. To maintain a level of per student expenditure sufficient to provide through and efficient education:
- F. To comply with all applicable statues, code and case law.

#### Support Services

The Board of Education expects operation and maintenance of the school plant and equipment to set high standards of safety, to maintain the health of students and staff, to reflect the aspirations of the community, to support environmentally the efforts of the staff to provide a good education and to preserve the community's major investment.

In order to provide services that sufficiently support the educational program, the Board establishes as broad goals:

- A. To provide a physical environment for teaching and learning that is safe and pleasant for students, staff, and public;
- B. To provide safe transportation for eligible students;
- C. To provide resources, facilities and assistance to meet the needs of the educational program as they develop.

#### Long-range Plans

In compliance with law, the Superintendent will develop a three-year comprehensive maintenance plan. The Board will review this plan and the District's five-year long-range facilities plan, and will update both annually with the advice of the Superintendent.
